Contract Agreement

THIS AGREEMENT made and entered into this ____ day of _____ 2020 between the **Municipal Government of San Vicente, Palawan** of the Philippines represented in the act by its **Municipal Mayor, HON. AMY R. ALVAREZ** (hereinafter called "the Entity") of the one part and **MACRORAIN TRADING** of **Fundador Road, Bgy. San Miguel, Puerto Princesa City** represented by **NOVE F. SEÑORIN** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited for a **Bids** for certain goods and ancillary services, viz., that **SUPPLY AND DELIVERY OF MATERIALS AND FITTINGS OF WATERWORKS MAINTENANCE FOR 3RD QUARTER REQUIREMENT, MUNICIPALITY/2020-001** and has accepted a bid by the Supplier for the supply of those goods and services in the sum of **TWO HUNDRED TWENTY-TWO THOUSAND FOUR HUNDRED NINETY PESOS AND FIFTEEN CENTAVOS (Php 222,490.15)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier' Bid, including the Technical and Financial Proposals, and all other documents/statements submitted including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the Entity's Notification of Award;and
 - (e) the Notice to Proceed
3. The Supplier shall provide and deliver the items within thirty (30) calendar days upon receipt of Notice to Proceed duly signed by the Head of the Procuring Entity;
4. The Entity shall impose one tenth (1/10) of one (1) percent of the total cost for each day of delay in the delivery of the goods;
5. The Entity have the right to reject defective items and any items that do not conform to the specification;
6. The Supplier shall replace defective/rejected items to meet the specification at no cost to the Entity;
7. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
8. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract; and
9. The **notarization** of this instrument shall be for the account of the Supplier.




