Invitation to Bid

1. The **MUNICIPAL GOVERNMENT OF SAN VICENTE, PALAWAN**, through the 2019 Continuing Fund of Municipal Economic and Enterprises Development Office (MEEDO) intends to apply the sum of **EIGHT HUNDRED THIRTY THOUSAND THREE HUNDRED NINETY PESOS (Php 830,390.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **SUPPLY AND DELIVERY OF HARDWARE MATERIALS FOR THE REHABILITATION OF PUBLIC MARKET ROOFING AND GUTTER, BGY. POBLACION, THIS MUNICIPALITY /2020-008**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **MUNICIPAL GOVERNMENT OF SAN VICENTE, PALAWAN** *through its Bids and Awards Committee* now invites bids for the **SUPPLY AND DELIVERY OF HARDWARE MATERIALS FOR THE REHABILITATION OF PUBLIC MARKET ROOFING AND GUTTER, BGY. POBLACION, THIS MUNICIPALITY**. Delivery of the goods is required within thirty (30) working days reckoned from the date stipulated on the Notice to Proceed (NTP). Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the ***BAC of the Municipal Government of San Vicente, Palawan*** through its Secretary and inspect the Bidding Documents at the address given below during **8:00 a.m to 5:00, Monday – Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **JULY 24 TO AUGUST 25, 2020** from the BAC Secretariat Office upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 1,000.00**.

The Bidding Document shall be issued to the prospective bidder or his duly authorized representative upon presentation of the printed copy of Philgeps Bid Notice Abstract to ensure that the organization name of the concerned bidder is included in the Document Request List (DRL).

6. The ***BAC of the Municipal Government of San Vicente, Palawan*** will hold a Pre-Bid Conference on **AUGUST 3, 2020, 2:00 p.m, at Malagnang Room, Municipal Government Center, San Vicente, Palawan** which shall be open to prospective bidders.
7. Bids must duly receive by the BAC Secretariat at the address below on or before **AUGUST 25, 2020, 1:15 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **AUGUST 25, 2020, 01:30 p.m @Malagnang Room, Municipal Government Center, San Vicente, Palawan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. ***The Municipal Government of San Vicente, Palawan*** reserves the right to reject any or all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
